A variance request by Stuart Nunn, Jr., RealtyAnalytix Advisors on behalf of Arnold Hite for a decrease in the minimum setback requirements for unzoned areas of Section 30-111. (7) of the Florence County Code of Ordinances for property located at 1611 Range Way, Florence shown on Florence County Tax Map No. 120, Block 1, Parcel 90.

Chairman Jacobs asked and the wetlands and the size of the addition would preclude you from going to your left in that storm sewer line?

Mr. Nunn responded yes.

Chairman Jacobs asked is there anyone here to speak opposed to this request?

There was no response.

Mr. Marion McDowell made a motion to approve the request. Mr. Bill Garner seconded the motion. The vote carried unanimously.
