# **Map Amendment:**

Map amendment No. 2010-13 requested by Stephanie Fancote on behalf of William Michael Nexsen to change the zoning district designation for property located at 1217 Pheasant Rd., Effingham shown on Florence County Tax Map No. 127, Block 1, a portion of Parcel 54 consisting of 1.02 acres from R-3, Single-Family Residential District to RU-1, Rural Community District.
