Any request for a continuance of your case(s) or protection, after the roster has been published, must be made in writing, to the Chief Administrative Judge for General Sessions no later than <a href="Wednesday, July 09">Wednesday, July 09</a>, 2014 at 5:00p.m. Failure to make such request as required herein will result in your case(s) being subject to trial during the upcoming Term of Court.

Failure of any party to appear without prior approval by the Court could result in Contempt of Court and/or the issuance of a Bench Warrant.
