SOLICITOR'S TRIAL ROSTER MARION COUNTY GENERAL SESSION COURT MAY 2014 TERM

Pursuant to Order of the Chief Administrative Judge, D. Craig Brown, there will be a Roster Meeting of all General Sessions cases on the Trial Roster before the <u>Honorable William H. Seals</u> on Monday, May12,2014 at 8:30 a.m. at the Marion County Courthouse.

All prosecutors, defense attorneys, law enforcement, and defendants are required to be at the Roster Meeting. If you, as the attorney of record, are unable to attend the Roster Meeting, then you need to have an attorney present at the Roster Meeting who can speak about the case with knowledge of its status (plea/trial, pending motions, discovery issues, etc.). Regardless of whether or not you, as the attorney of record, are able to attend the Roster Meeting, the defendant(s) will still be required to attend until excused by the Solicitor.

Any request for a continuance of your case(s) or protection, after the roster has been published, must be made in writing, to the Chief Administrative Judge for General Sessions no later than <u>Wednesday</u>, <u>May 7, 2014</u>. Failure to make such request as required herein will result in your case(s) being subject to trial during the upcoming Term of Court.

Failure of any party to appear without prior approval by the Court could result in Contempt of Court and/or the issuance of a Bench Warrant.
