

**SOLICITOR'S TRIAL ROSTER

Pursuant to Order of the Chief Administrative Judge Thomas A. Russo, there will be a Roster Meeting of all General Sessions cases on the Trial Roster before the **Honorable Edgar W. Dickson** on **Monday, September 30, 2019 at 9:00a.m.** in the **3rd floor Courtroom,** Florence County Judicial Center, 181 N. Irby Street, Florence, SC.

All prosecutors, defense attorneys, and defendants are required to be at the Roster Meeting. If you, as the attorney of record, are unable to attend the Roster Meeting, then you need to have an attorney present at the Roster Meeting who can speak about the case with knowledge of its status (plea/trial, pending motions, discovery issues, etc.). Regardless of whether or not you, as the attorney of record, are able to attend the Roster Meeting, the defendant(s) will still be required to attend unless excused **by the Solicitor.**

Any request for a continuance of your case(s) or protection, after the roster has been published, must be made in writing, to the Chief Administrative Judge for General Sessions no later than **Wednesday, September 25, 2019 at 5:00p.m.** Failure to make such request as required herein will result in your case(s) being subject to trial during the upcoming Term of Court.

Failure of any party to appear without prior approval by the Court could result in **Contempt of Court** and/or the issuance of a **Bench Warrant.**
