# What is Early Crime Prevention?

Early Crime Prevention is a juvenile diversion program designed to divert children below the age of 12 who are 1<sup>st</sup> time, non-violent/non-status offenders out of the Family Court System. The hearings are conducted by trained community volunteers in an informal arbitration setting.

The main goal of the program is to educate and reach out to the juvenile to try and prevent any further involvement with the Juvenile Justice System.

### How Does It Work?

The Early Crime Prevention Program hearing is not conducted as a formal court hearing. This is an informal process where strict rules of evidence do not apply.

- $\triangleright$ The Arbitrator will resolve the case through an arbitration process where all parties that are involved in the case are present. The child, his or her parent(s), the victim, and the law enforcement officer are given the opportunity to express themselves on the issues of whether the child has violated the law, and if so, what sanctions are appropriate under the circumstances and to help the child understand the ramification and consequences of his/her actions. The Arbitrator will be able to provide any necessary community resources that are determined to assist the child and his/her parents.
- A dispositional agreement is written with sanctions such as; apology letters, home restriction, acts of kindness, or any other action the parent and Arbitrator agree is appropriate. Also, there is a \$50.00 fine imposed, where the child must work and earn money to pay back the community.
- Once completed, the case is closed with no juvenile record being established. If the juvenile fails to complete, the case is sent back to the Department of Juvenile Justice for further action.

Goals of Early Crime Prevention

#### **Program**

- To provide a system by which children who commit certain offenses may be dealt with in a speedy and informal manner at the community level.
- To enable trained citizens, acting as Arbitrators, to objectively evaluate the child and circumstances in order to determine the most appropriate disposition considering the child, victim and the community.
- To provide an early intervention process for younger children in hopes of preventing further involvement with the Juvenile Justice System and Family Court.
